**Registration Requirements** (This shall not apply to a candidate of a political party participating in its first direct primary election subsequent to its qualification as a political party pursuant to Section 5100.)

1. Be registered with the political party, as shown by affidavit of registration, continuously for not less than three months immediately prior to filing nomination documents (**Applicable to registered voters with a prior registration and party affiliation as No Party Preference or registered with an unqualified party, then re-registered with a qualifying party for three months on or before September 8, 2023**).

--- OR ---

2. For as long as they have been eligible to register to vote in California (**Applicable to new residents, new citizens and anyone turning 18 years old after September 8, 2023**).

3. Not have been registered as affiliated with **any other qualified political party** within twelve months immediately prior to the filing of the declaration of candidacy. CEC §8001(a)(2)

**Registration Requirements**

**Peace and Freedom Party**

1. Have been registered as a member of the Peace and Freedom Party for not less than 30 days prior to filing nominations. **(Must be registered with the Peace and Freedom Party on or before November 8, 2023).**

**Green Party**

1. Have been registered as a member of the Green Party for not less than 3 months prior to filing nominations. **(Must be registered with the Green Party on or before September 8, 2023).**
