Candidate may then, prior to the close of the nomination period, pay the pro rata portion of the filing fee to make up the deficiency. (E. C. §§ 8061, 8105 and 8106)
<b>JAN. 20 (Sa)**</b> E-73**	<b>FEB. 8 (Th)</b> E-54	NOMINATION PERIOD First and last day to circulate and leave nomination documents for examination and certification. Candidate must also file a Declaration of Candidacy and Ballot Designation worksheet during this period. (E. C. §§ 8028, 8040, 8041, 8062 and 10704 and 13107.3) NOTE: Fax not acceptable. Filing fees shall be paid at the time the candidate obtains nomination forms from the county elections official. (E. C. §§ 8105 and 8106(b)(3))

C. § 14212)</li> <li>NOTE: If at the hour of closing, there are any other qualified voters in the polling place or in line at the door, who have not been able to vote since appearing, the polls shall be kept open a sufficient amount of time to enable them to vote.</li> <li>(E. C. § 14401)</li> <li>VOTE BY MAIL BALLOTS RETURNED-8:00 P.M.</li> <li>Last day for Vote By Mail ballots to be received or turned in personally by the voter at any polling place in the jurisdiction. 		<b>NOTE:</b> On <b>April 12, 2018</b> the Registrar- Recorder/County Clerk is scheduled to certify the election results to the SOS. On <b>May 1, 2018</b> , the Board of Supervisors is tentatively scheduled to declare the election officially concluded.

If any candidate receives a majority of all votes cast at the special primary election, he or she shall be declared elected and the special general election shall not be held. (E.C. § 10705)

If no candidate receives a majority of votes cast at the special primary election, the names of the top two vote getters shall be placed on the special general election ballot. (E.C. § 10706)
