ACCESS TO VOTING FOR RESIDENTS EXPERIENCING HOMELESSNESS (ITEM NO. 10, AGENDA OF SEPTEMBER 17, 2019)

On September 17, 2019, the Board approved the Access to Voting for Residents Experiencing Homelessness motion which directed the Registrar-Recorder/County Clerk (RR/CC), in collaboration with the Chief Executive Office (CEO) and the Los Angeles Homeless Services Authority (LAHSA), to conduct outreach to homeless service providers, assess homeless shelters or facilities in close proximities to shelters to serve as vote centers or establish pop-up vote center services and continue to conduct voter registration at venues that serve residents experiencing homelessness.

Outreach to Homeless Service Providers

The RR/CC collaborated with the CEO and LAHSA and conducted Voting Solutions for All People (VSAP) presentations at various community meetings with homeless service providers (see Attachment A). Presentations included an overview of VSAP including the extended 11-day voting period, the vote center model, the new Ballot Marking Device (BMD), the Electronic Pollbook (ePollbook), rotating demonstration centers, and the VSAP Flex Program. The VSAP Flex Program lends a special focus on voters with distinct needs such as people experiencing homelessness, seniors, voters with disabilities, and incarcerated voters. This program incorporates Flex Vote Centers that allows all the services and equipment found at a traditional vote center to be located at a shelter or facility for a half or full day. The schedule will depend on a variety of factors including availability, regional distribution and the expected number of voters. A Flex Vote Center will consist of 2 RR/CC staff members, 1 volunteer provided by the organization, an ePollbook and 1 or 2 BMDs. VSAP informational flyers, and brochures were also provided and made available to take back to agencies and consumers.

Assess Shelters/Facilities to serve as Vote Centers or Pop-up Vote Centers

Determining the most suitable vote center locations required a robust, data-driven process that integrated State and local requirements with local spatial and socioeconomic conditions while forecasting human behaviors and patterns. To finalize and confirm vote centers for the March 2020 Primary Election, the Department is conducting comprehensive surveys of each potential site to ensure accessibility and appropriate power and network connectivity. Over 1,200 sites have passed surveys and are currently in the process of finalizing Facility Use agreements. To date, preliminary data has identified approximately 34 vote centers located in close proximity to homeless shelters or facilities (see Attachment B). It is important to note that the finalization of vote centers is ongoing and the data reported may change. Alternatively, the Flex Vote Center program does not require an extensive site survey and may be a better option for homeless service providers. Information on the Flex Program and applications to become a Flex Vote Center was provided to homeless service providers via email as a follow-up to each meeting (see Attachment C). Approximately 9 agencies interested in serving as Flex vote centers have submitted an application and will work with RR/CC staff for coordination and scheduling (see Attachment D).

Voter Registration for Residents Experiencing Homelessness

Additionally, since January 2019, the RR/CC Community and Voter Outreach (CVO) team has attended over 25 community outreach events specifically focusing on educating and assisting people experiencing homelessness with voter registration. The CVO team will continue to look for outreach opportunities to serve homeless communities. The RR/CC will also continue to work with LAHSA in coordinating additional meetings, events, and the distribution of information amongst community providers.
