



## Assembly Bill 878 Public Notice

RE: Fictitious Business Name (FBN) Filing Requirements

Per Assembly Bill 878, Chaptered 6/29/23, and effective January 1, 2024:

Sections 17913, 17919, 17920, 17922, and 17923 of the Business and Professions Code Sections were amended to remove the registered owner/registrant's residence address from all Fictitious Business Name (FBN) statement filings and replace it with the business' mailing address for privacy purposes. This includes originals, amendments, renewals, abandonments, and withdrawal FBN filings, as well as the Proof of Publication. Sample updated FBN form is shown on the next page.
