During this period any person may file a writ of mandate or an injunction to require any or all of the material to be amended or deleted. (E. C. § 9509)

	Any Vote By Mail ballot cast under this division shall be timely cast if it is received by the voter's elections official via the United States Postal Service or a bona fide private mail delivery company no later than three days after election day in addition to the provisions set forth in E. C. 3020, Sections 1 and 2. (E. C. § 3020(b) Section 1 and 2)
JUNE 3 (Th)	OFFICIAL CANVASS
E+2	The canvass of election returns shall commence no later than the first Thursday following the election. (E. C. § 15301)
JUNE 14 (M) E + 13	COMPLETION OF OFFICIAL CANVASS The county elections official shall prepare a certified statement of the results of the election and submit it to each jurisdiction within 30 days of the election. (E. C. § 15372)
