The county elections official shall print any such list that is timely received from the state party chairperson in the sample ballot. (E.C. § 13302(b))
APRIL 10 (W) E-55		CERTIFIED LIST OF CANDIDATES Last day for the Secretary of State to send the certified list of candidates to the county elections official.
APRIL 20* (Sa) E-45*		MILITARY AND OVERSEAS BALLOTS Last day for county elections official to transmit ballots and balloting materials to absent military or overseas voters who have requested them by this date. (E.C. § 3114)
APRIL 25 (Th) E-40	MAY 14 (Tu) E-21	OFFICIAL SAMPLE BALLOT BOOKLETS An Official Sample Ballot Booklet shall be mailed to each voter in the district during this period. (E. C. § 13303)
MAY 6 (M) E-29		PRECINCT BOARD MEMBERS AND POLLING PLACES – APPOINTMENT Last day to appoint board members and designate polling places. A notice of appointment shall be mailed to each member appointed. (E. C. §§ 12286, 12307 and 12319)

		The processing of vote by mail ballots may commence on the 10 th business day before the election, but the results of the tally shall not be released until after the polls close. (E. C. § 15101(b))
MAY 25 (Sa)		TALLY CENTER LOCATION – PUBLICATION
E-10		On or before this date a notice specifying the public place to be used as the central tally location for counting the ballots shall be published once in a newspaper of general circulation within the jurisdiction. (E. C. § 12109 and Govt. § 6061)

MAY 28 (Tu) 5:00 P.M. E-7		POLLING PLACES – PUBLICATION Not later than this date, a list of polling places for each precinct shall be published once in a newspaper of general circulation within the district. (E. C. §§ 12105, 12106 and Govt. Code § 6061)
		COMPUTER PROGRAM TO SECRETARY OF STATE Last day to deposit copy of computer vote counting program and Certificate of Logic and Accuracy Test with Secretary of State. (E. C. § 15001)

	NOTE: If at the hour of closing, there are any other qualified voters in the polling place or in line at the door, who have not been able to vote since appearing, the polls shall be kept open a sufficient amount of time to enable them to vote. (E. C. § 14401)
	VOTE BY MAIL BALLOTS RETURNED – 8:00 P.M. Last day for Vote By Mail ballots to be received or turned in personally by the voter at any polling place in the district. An authorized representative may return the voted ballot under specified conditions. (E. C. §§ 3017, 3020 and 3021)
