		NOTE: If at the hour of closing, there are any other qualified voters in the polling place or in line at the door, who have not been able to vote since appearing, the polls shall be kept open a sufficient amount of time to enable them to vote. (E. C. § 14401)
		VOTE BY MAIL BALLOTS RETURNED – 8:00 P.M. Last day for Vote By Mail ballots to be received or turned in personally by the voter at any polling place in the district. An authorized representative may return the voted ballot under specified conditions. (E. C. §§ 3017, 3020 and 3021)
		Any Vote By Mail ballot cast under this division shall be timely cast if it is received by the voter's elections official via the United States Postal Service or a bona fide private mail delivery company no later than three days after election day in addition to the provisions set forth in E. C. 3020, Sections 1 and 2. (E. C. § 3020(b) Section 1 and 2)
