The postback file contains payment information with warrant numbers that is imported back into EMS to update payment information.
Precondition	 User has required Security Level in Election Worker module. Election Worker Fees will be auto populated some fields pre defined based on job title, training, bonus etc Supervisor will approve attendance records and will push record to Payroll. Users will do quality assurance to make sure fees are valid.
ExpectedResult	Create a file using EMS Election Worker Payroll data in the format (text tab delimited), required by the Auditor Controller.
DetailedProcessFlow	 Supervisor will review Payroll Exception Report. Supervisor will create a File Reconciliation report in xls format. Supervisor will generate payroll file. The system will generate the flat file in the format required by the L.A. County Auditor Controller. Supervisor will sent the file to the Auditor Controller via FTP. Supervisor will sent email to Auditor Controller to notify them a file has been transmitted. Auditor Controller will process file, generate payment warrants, mail payments and generate Payroll Postback file for Registrar-Recorder. Postback Payroll file is received via FTP from the Auditor Controller 1 day after submitting payroll file. Supervisor will upload the Postback file into EMS to update the payment date, amount and warrant numbers.
