**UPDATE ON HAVA GRANT VOTER EDUCATION COMPONENT**

Following your Board's September 14<sup>th</sup> agreement to accept \$2.5 million in Federal Help America Vote Act (HAVA) grant funds, we began finalizing the voter education and outreach component as outlined in the extensive grant application. The overriding goal of this paid advertising campaign is to reduce voter confusion and error by educating voters on how to use new voting equipment and explain the three voting options available to all Los Angeles County voters. Themed advertisements (30-second spots) will begin airing on cable television channels throughout the County beginning next week. A video tape of these advertisements, in English and in Spanish, is enclosed.

The first television spot outlines voters' three choices to cast a ballot either via touchscreen early voting, absentee voting by mail, or election day polling place voting. A second spot demonstrates how to use the InkaVote system. The third spot solicits pollworker applications and will run free of charge through various cable providers as a public service announcement.

Also enclosed are samples of graphics materials featuring the new "Got Dots?" voter education campaign to familiarize voters with InkaVote, the new optical scan voting system that many voters will use for the first time on November 2. Included is a copy of the redesigned sample ballot cover, a voter information page that will appear in the sample ballot reminding voters to make ink marks instead of punching, and a poster that will form the basis of billboard and bus panel advertising that will be seen throughout the County in October. The print and radio media components of the advertising campaign are still under development. Our next update will include copies of that advertising text.
