WEEKLY STATUS REPORT #1: NOVEMBER 7, 2006 GENERAL ELECTION

Introduction of InkaVote Plus

Implementation plans are on schedule for the rollout of InkaVote *Plus* (descriptive brochure attached). This enhancement to the County's voting system that will allow voters to check ballots for errors and will provide independent voting for persons with disabilities at any voting location countywide. A separate memo will be forthcoming describing voter outreach and education efforts.

Polling Places and Pollworkers

Polling locations have been finalized for all 5,029 voting locations. As of today, more than 21,000 pollworkers (of 27,000 needed) have been recruited to serve on election day. Pollworker training classes begin this week – a total of 490 classes held throughout the County -- and will continue through November 5.

Sample Ballots

Mailing of sample ballots to the County's 3.8 million registered voters has just begun and will continue over the next few weeks.

Absentee Ballot Mailings

Absentee ballots have been mailed to nearly 15,000 military and overseas voters. Absentee ballots are ready to mail to nearly 380,000 permanent absent voters on the first day permitted (October 9). The deadline to apply for an absentee ballot is October 31.
