WEEKLY STATUS REPORT #3: NOVEMBER 7, 2006 GENERAL ELECTION

Snapshots of Election Preparation Activities

Attached are photos showing several key processes underway to prepare for Election Day including:

- Approximately 400,000 absentee ballots loaded onto pallets these were delivered to the U.S. Postal Service for mailing on the first legal date, October 9
- InkaVote Plus precinct ballot readers and audio ballot booths lined up for programming at the new warehouse/operations center in Santa Fe Springs
- Press conference introducing InkaVote Plus equipment at Santa Fe Springs facility

Voter Registration Deadline/Statistics

Yesterday was the last day to register or re-register to vote for the November 7, 2006 election (we staffed three sites in the County through midnight). We received a flood of voter registration forms on yesterday's deadline: 17,342. This is comparable to the number of voter registration forms we received on the deadline for the November 2002 and October 2003 (Recall) elections, albeit significantly less than received immediately prior to the November 2004 election.

Sample Ballots

Earlier this week the final mailing of all Sample Ballots to 3.9 million registered voters was completed. Supplemental mailings to voters who registered to vote very recently began Oct. 20 and will continue through the end of the month.

Polling Places and Pollworkers

As of today, more than 96% of needed pollworkers have been recruited to serve on Election Day. Recruitment continues including replacement of approximately 200 pollworkers daily due to cancellations. Pollworker training classes continue through November 5.

Absentee Ballot Mailings

Absentee ballots have been mailed to 544,000 voters. Thousands of applications continue to arrive daily and are processed and mailed within 24 hours of receipt. The deadline to apply for an absentee ballot is October 31.

Approximately fifteen percent of the absentee ballots have been voted and returned to our office.

Testing of election night tally programs is in progress. This event is proceeding as scheduled.

5. Mail Sample Ballots

10/28/2006

The initial sample ballot mailing to over 3.8 million registered voters began on September 28, 2006 and continues through October 28, 2006. Supplemental sample ballot mailing (to persons registering or re-registering to vote up until the October 23 deadline) will occur throughout October. This event is proceeding as scheduled.
